Throughout this module, students are working independently to choose and learn about a social justice issue that intersects with criminal justice. There are several issues criminal justice officials must react to during various decision-making points in the criminal justice system. Criminal justice officials must frequently respond to broader social problems in an ethical manner.

This module contains several related assignment, so be sure to read through all the pages under Module 3 in this Webcourse.

Purpose of this Assignment

In this course module, students are exploring a social justice issue/topic that is related to criminal justice. As you know, everyone has joined one of the following social justice groups:

- Behavioral health (e.g., drug use, mental health)
- Environmental justice
- Gender justice
- Hunger & Homelessness

As part of this project, students may choose to write a formal Experiential Paper. The paper is designed to meet several course learning objectives and demonstrate integrative learning. Generally, the paper requires you to describe, apply, and evaluate one ethical theory to a social justice issue that is related to (intersects with) criminal justice.

In preparation for writing the paper, this assignment requires you to submit a bibliography - a list of potential sources you **may** cite and reference in the final paper. A bibliography is a list of sources to be consulted in preparation for writing a paper, article, or book. You may or may not use, cite, and reference all the sources from your bibliography in your paper's text and references.

Bibliography Requirements

In this bibliography, you will find and list (using APA style) **12 scholarly sources** on your social justice topic/issue and how it relates to criminal justice. You will also include at least one source for an ethical theory to be used in your paper. (Hint - Your text is a great source for the ethical theory!)

Be sure to do the following in the bibliography:

- Include 12 scholarly, primary sources by searching in the UCF Library databases
- Include the course text book (if you have it), as it will count as one of your sources (even though it is a secondary source)

- Do not count secondary sources, such as websites or text books (other than the course text), as one of the 12 scholarly sources. You may include non-scholarly, secondary sources, but, I repeat, they do **not** count toward the 12 scholarly sources
- Use APA citation style
- Use proper Word formatting

Finding Articles & APA Citation Style

This bibliography requires scholarly sources be included. Scholarly sources are primary sources (original writings/articles) found in scholarly journals. For more information on finding scholarly articles, see page in Webcourses entitled Finding Articles.

Criminal justice scholarship traditionally uses APA citation style. For more information on APA style, see the page in course entitled Citing and Summarizing an Article

You may also find the "Research Guide" and "UCF Library Tools" pages listed at the left of this course to be quite useful.

Word Formatting

APA requires double spacing and hanging indents. Here's a video on formatting paragraphs in Word.

Turnitin and Plagiarism

Turnitin.com has been enabled through Webcourse and will be used to check for plagiarism. Turnitin.com is an automated system which instructors can use to quickly and easily compare each student's assignment with billions of web sites, as well as an enormous database of student papers that grows with each submission. Accordingly, you will be expected to submit assignments through the Canvas Assignment Tool in electronic format. After the assignment is processed, as an instructor I receive a report from turnitin.com that states if and how another author's work was used in the assignment. For a more detailed look at this process.
