# FIRST AMENDMENT TO THE BURNETT HONORS COLLEGE AND

## SEMINOLE STATE COLLEGE GRINDLE HONORS INSTITUTE HONORS TRANSFER STUDENT ARTICULATION AGREEMENT

This First Amendment ("Amendment") to The Burnett Honors College and Seminole State College Grindle Honors Institute Honors Transfer Student Articulation Agreement ("Agreement") is made and entered into between the University of Central Florida Board of Trustees ("UCF") and Seminole State College of Florida District Board of Trustees ("College"). Capitalized terms used in this Amendment but not defined shall have the meaning given to them in the original Agreement.

UCF and College agree to amend the Agreement as follows:

1. The text of Subsection 5 of the "Student Provisions" section of the Agreement is deleted and replaced with the following: "5. Submitted a complete Burnett Honors College University Honors application by the posted deadline available at <a href="https://honors.ucf.edu/university-honors/aa-transfer-students/">https://honors.ucf.edu/university-honors/aa-transfer-students/</a>".

Except as amended above, the Agreement remains in full force and effect and is otherwise unmodified.
