

# General Undergraduate Requirements Committee January 19, 2022 at 11:00 AM – 12:00 PM

#### **MINUTES**

The **November 16, 2021** meeting minutes were approved.

# **Approval of CAH Courses:**

## AMH 4174 – Emancipation and Reconstruction (Pineda):

- The course is up for Gordon Rule Writing approval, and it has been accepted through the college.
- The course is writing intensive.
- Responses to Questions and/or Comments
  - They expect enrollment of between 35 and 45 students.
  - The course is replacing past courses taught by a professor that is retiring.
  - A professor will be hired in the future to replace the professor that is retiring.
  - The professor that is proposing the course is trained in African American History.

- The course lines up with other courses in our program since there are lower-level courses that lead up to this one.
- Classes are usually capped at 45 and lately they have been capped at 40 so it allows for feedback for the instructor for substantial revision.
- An addition about revision should be included in the description since it is part of the Gordon Rule requirements.

#### AML 3632 - Puerto Rican Literature (Jones):

- This course is a new elective which a faculty member has proposed and has been approved through UCRC as a new course, and they are seeking diversity designation on it.
- It speaks to the experience of Puerto Rican people in Puerto Rico and the diaspora of the United States, Florida especially. It uses a mix of literary text from authors of those areas.
- It is 3000 level, which is good for transfer students of which they have a lot.
- Responses to Questions and/or Comments
- Under the category of Diversity-Outcomes in Kuali it details the following as student learning outcomes the course needs to address:
- increased awareness of racial diversity in Caribbean and Puerto Rico
- awareness of how the political, social, and cultural history of Puerto Rico is expressed in its art
- a greater understanding of aesthetic, historical, sociopolitical, and cultural issues related to and expressed in Puerto Rican art
- an awareness of the significance of Puerto Rico as a US possession in the Caribbean and its origins.
- Whether the students are successfully meeting the student learning outcomes will be assessed through their success with the different assignments.
- Diversity classes don't need to have an out of classroom component.
- The committee will review the posted Kuali information and will vote in the next days.

#### THE 3240 - Evolution of Musical Theatre (Brown):

- The course is an existing 3000-level course which he has taught for several years.
- The course will now deepen the integrity of the class and require more investment from the students with their writing.
- It will include assignments, projects and what they call "extra critique" for Theatre majors with the goal of reflecting the writing assignments for the class.
- Currently they use a textbook and take quizzes from the information in the textbook. They want to add a layer that is more experiential.
- The proposal would meet the criteria for Gordon Rule; it would add more integrity to the course and appeal to more students.
- Responses to Questions and/or Comments
  - The last enrollment was 134, which might be a little more than usual, but he doesn't believe it would be an issue with grading.
  - o The different assignments were summarized.
  - Writing Across the Curriculum headed by Laurie Pinkert was introduced as support for the teaching assistants since it has training available.

# The committee discussed the process to be followed for approval:

- A Qualtrics will be sent out for voting purposes.
- An option can be included where you can include comments and whether it is approved, disapproved or approved contingent upon revision.
- The presenters will be contacted.
